Insects include aphids, ants, beetles, caterpillars, mites, scale, snails, termites & whiteflies. "Rodents include rats, mice, rabbits, squirrels & voles. This product dries on porous, allowing moisture & nutrients to pass (ex. pruned branches & foliar feeding) through coated surfaces, compared to latex paint & tar based products.

CAN CONTENTS: 1 bag powder & 1 oil vial.

RECOMMENDED APPLICATION: Up to three (3x) times per year for maximum repellent protection against insects and rodents. One coat per year may be sufficient protection from sun damage.

BRUSH ON DIRECTIONS: 1) ADD POWDER AND OIL VIAL CONTENTS TO CAN. 2) FILL CAN NEAR TOP WITH WATER, 3) STIR WELL. 4) ADD MORE WATER, IF NECESSARY TO HAVE A FULL CAN OF PRODUCT 5) STIR EVERY 5-10 MINUTES WHILE USING THIS PRODUCT TO ENSURE UNIFORMITY OF CONTENTS WHILE APPLYING PRODUCT TO TREE TRUNK AND BRANCHES. 6) APPLY WITH A PAINT BRUSH. HISE RESTRICTIONS

Always test a small area and wait a few days to ensure damage does not occur. First year bark growth on some plant species are typically too waxy for good adhesion of this product, requiring second and third coats to accomplish full coverage. Do not consume this product. If product gets into eyes, flush immediately with running water for at least 15 minutes. Wearing gloves is recommended to avoid any possibility of skin irritation.

STORAGE AND DISPOSAL

It is recommended that you only mix what you intend to use on the same day. Unused liquid (mixed) product may be refrigerated for up to 2 weeks, or frozen for up to 2 years. Powder that has not been mixed may be stored in a cool and dry area for up to 5 years. RECYCLE May only be used if the requirements of 205,206(e) are met, which requires the use of preventive.
